

## Harbor String SOLO (HSS) Contract of Service

This contract, for the services of the Harbor String Solo, herein called HSS at P.O. Box 10166, Virginia Beach VA 23450, and the undersigned client of services, herein called CLIENT for the event described below, made this date \_\_\_\_\_. HSS is engaged on the terms and conditions hereof, and agrees to be bound by the terms and conditions.

THEREFORE, it is mutually agreed between the parties hereto as follows:

7. PAYMENT TERMS: Final payment **due on or before** the day of the event.

a. CLIENT will render a deposit check for \$ 100, payable to HARBOR STRING QUARTET at least 30 days prior to the engagement, to hold the date and to act as earnest money. (Please note: Your date and time is not reserved until contract and deposit have been received.)

b. CLIENT will render remaining amount due upon the HSS arrival at place of engagement payable to the individual musician to be named OR a full amount check made out to HARBOR STRING QUARTET.

8. CLIENT shall make arrangements to take care of the Soloist's technical needs, which in this case are:
  1. Sufficient performing space (approx. 4' x 4') where HSS musician can view ceremony.
  2. Sufficient lighting.
  3. One armless chair.
  4. Outdoor temperatures must be between 60 degrees and 90 degrees with shelter from rain and direct sunlight.

9. HSS shall provide the musician required to perform the engagement and performer may or may not be the same performer as listed on the web site or other promotional material(s) but in all cases shall be a proficient musician capable of performing the engagement.

10. If CLIENT cancels or postpones the engagement without written notice to HARBOR STRING QUARTET within fifteen (15) days of the scheduled engagement described herein, CLIENT shall pay HSS the full wage agreed upon. If written notice is extended to HSS between fifteen (15) and thirty (30) days prior to engagement, the deposit shall be retained by HSS. If CLIENT renders written notice of cancellation thirty (30) days or more prior to the scheduled event, CLIENT shall receive a full refund of their deposit.
